O'Brien/Aflac NY Teleworking, 605 Schooner Court - Home Occupation (18.065)

PUBLIC HEARING SET. Board set a Public Hearing for the May 14, 2018 meeting for the proposed Home Occupation request for a in-home telecommuting insurance office.

**Dirad, 5 Corporate Drive - Change of Use/Tenant & Sign (18.052 & 18.053) APPROVED.** Board approved the Change of Use/Tenant and Sign requests for a telecommunications company call center in approximately 2,500 SF of the existing building.
