HALFMOON: A Brief History to 1899

Halfmoon occupies a part of the southeastern corner of the county. It is bounded on the north by Malta and Stiliwater, on the east by the east bounds of the county, on the south by Waterford and the south line of the county, and on the west by Clifton Park. The Revised Statutes (1899) define the town as follows:

The town of Halfmoon shall contain all that part of said county bounded northerly by Anthony's Kill, easterly by the east bounds of the county, southerly by Waterford and the south bounds of the county, and westerly by a line beginning at the outlet of Round Lake; then running south to the east side of William Gates' grist mill; then southerly through the centre of the mill pond across the bridge over said pond; then southerly to the west side of Joseph Merrill's dwelling house; then south to the Van Schaick line, then along said line to the Mohawk river, varying the same at the dwelling house of Ephraim Stevens so as to leave the same on the west side of the line.

The surface is undulating and contains several small streams running in places through narrow ravines. The eastern section, extending along the river bank, is flat and fertile, as is most of the land. Anthony's creek and Dwaas' kill flow into the Hudson, and Steena kill into the Mohawk. The Erie canal passes through the western half of the southern part of the town, running nearly parallel to the Mohawk river. The Champlain canal traverses the eastern part of the town from north to south. The Delaware & Hudson Canal company's railroad runs nearly parallel with this canal, and east of it, from Waterford to Mechanicville, running thence in a westerly direction about parallel with the north line of the town. The Fitchburg railroad also extends westerly from Mechanicville nearly parallel with the northern line of the town.

The earliest settlements in Halfmoon located on the banks of the Mohawk about 1680. Killiaen Vandenburgh built a home near Dunsbach's Ferry in 1718. The earliest building in Mechanicville doubtless was Gates's tavern. Henry Bailey had a tavern about a mile below, near the river, soon after the Revolution, perhaps earlier. Shibael Cross had another at Middletown before the Revolution.

Mechanicville is the principal village in Halfmoon. It lies partly in the northeast corner of the town and partly in Stillwater. It is a manufacturing and railroad centre of considerable importance. Here are located large shops of the Delaware & Hudson and the Fitchburg railroads, the immense plant of the Duncan company, manufacturers of fine paper; two large sash and blind factories, two large brick kilns, four knitting mills, a shirt factory, important lumber yards, a factory for manufacturing electrical goods, and other manufactures. The Duncan company is supplied with power principally from a dam across the Hudson river, In 1897 and 1898 a second large dam was erected in the Hudson for the development of power for transmission to the works of the General Electric company at Schenectady, about fifteen miles away. The electric current will be transmitted from Mechanicville to Schenectady by heavy insulated wires. The village has excellent railroad facilities, including, beside the steam roads mentioned, an electric line between Mechanicville and Stillwater. A line extending southward and connecting with Troy and Albany is in course of construction, and plans are being made for an extension to Saratoga Springs. The school system has undergone great improvements in recent years, and two new school buildings are soon to be constructed. There are five churches in the village-Baptist, Methodist, Episcopal, Presbyterian, Protestant Episcopal and Roman Catholic. There are also a Masonic lodge, and Odd Fellows lodge, three social clubs and several other fraternal organizations. It also has a well organized and equipped fire department. Mechanicville was not incorporated by law as a village until 1870. It was chartered by the County Court in July, 1859, and at the first election, September 10, following, ninety-five votes were cast. These trustees were elected: Cyrus Gilbert, Stephen Burtis, Lewis Smith, Job G. Viall, A. A. Buckhout. The board of trustees elected Lewis Smith chairman and William P. Harris clerk. Until 1870 the chief executive officer of the village was the chairman or president of the board of trustees. These officers were:

There are five hamlets in Halfmoon. Newton is located about two miles southwest of Mechanicville; Smithtown about two miles south of Newton; Clifton Park west of the centre of the town near the Clifton Park town line; Crescent just north of the great bend in the Mohawk; and Middletown about a mile easterly from Crescent. The First Baptist church of Halfmoon, located at Middletown, organized in 1835, succeeded the Baptist church at Newtown, long since extinct. The Second Baptist church of Halfmoon, at Clifton Park, was founded in 1841, the M. E. church at Smithtown about 1870, the M. E. church at Crescent in 1852, the Reformed Protestant Dutch church of Middletown (now extinct) in 1791, and the M. E. church at Coon's Crossing about 1858.

Half moon was one of the original districts of Saratoga county, the other being Saratoga. In 1816 Waterford was set off, the name of Halfmoon then becoming Orange. The old name was restored in 1820. Clifton Park was taken off in 1828. The district of Halfmoon was organized as a part of Albany county in 1772, as a town of Albany county in 1788, and as a town as at present constituted in 1828. Davey was elected to the office, and was reelected in 1896 and 1898.

This history, while it ends in 1899, should be useful particularly for the names of town officers, most of whom, are found in the records in this inventory.)

Introduction to Inventory:

Mission: The official records created by the Town of Halfmoon, Saratoga County that are of permanent value for their historical importance, for their use in the current operations of the town government, or for their use as evidence in any legal proceedings of the town requires that these records be preserved and made accessible to the staff of the town, to the citizens of the town and to researchers studying the history of the town. Some records must be preserved as permanent, according to state law, while other records may be disposed after time periods designated by state law. The records in this project are the historical records of the town rather than contemporary records. These records have been preserved for decades (in most cases for over a century) and they are not scheduled for disposal. These records may have some contemporary use in daily work or legal actions, but that is unlikely. The significance of the records inventoried here is the light that they shine upon the history of the Town of Halfmoon and for that reason are being kept permanently for town staff and research by historians and genealogists.

Staff: The staff with responsibility for the preservation and access of the town records includes the Town Clerk and Deputy Town Clerk and staff of the Town Clerk's Office. The Town Clerk, with the assistance of the Town Attorney as needed, acts as the Records Management Officer for the town. There is no staff person whose sole duty is the preservation and access for the town records; the staff of the Town Clerk handles the care of the records.

The following pages are an inventory of the historical records found in the vault of the Town Clerk's Office in Halfmoon, New York. The bound records (chiefly Town Board and other Board minutes and the Vital Records) are generally in very good condition. The bound records, in a variety of sizes, are filed together on shelves in the vault and are not mixed with the loose documents found in the "bankers" boxes. In a very few cases there are loose documents from the same office as those found in the bound volumes of records. There are approximately 202 volumes, either bound or in 3-ring binders. There are 34 boxes of loose documents. These thousands of documents are filed by town office, i.e. Highway Department, Overseer of the Poor, Justice of the Peace, etc. The documents for each of these offices were usually, though not always, found together. Thus, part of this project has included recreating these series of records for each office. In most cases, a brief statement is made about the history of the office that created the records in order to provide context for users of the records.

A word about condition of the records. The records were uniformly folded, many times very tightly folded (in most cases for over a century), with dust adhered to the document, and with hundreds of pins and other devices holding them together. Many of the documents, though not all, have been unfolded and all pins and any paper-clips were removed. The documents were not cleaned as this will require a major investment of time (much more than this project would allow). Some documents are very tightly folded or rolled and have been left as is. Unfolding or unrolling these documents will require humidification to increase the flexibility of the paper allowing it to be unfolded and flattened. This will usually need to be done prior to cleaning and flattening. That said, the majority of the historical records inventoried are in good condition except for the dust that has become adhered to them. They may be used by researchers without fear of damage. Gloves should be used by researchers and staff to keep their hands clean and the documents safe from any further damage. The records have been placed in new clean folders and boxes, although the folders and boxes are not acid-free. It should also be noted that the dates given in this inventory are accurate, but should not be considered complete or perfectly accurate as this was inventory is not done at the item-level and many of the documents are tightly folded and could not be flattened to be examined in detail.

Some documents were scanned by a commercial scanning company prior to this inventory and were kept separate from the bulk of the collection. Wherever possible these scanned documents have been returned to the records of the office that created them, i.e. scans of Highway Department records returned to that department's record series. However, the scanned documents were not refiled in the particular order from which they came. This was not done because it was not known from exactly where they originated. Therefore, each series has a file of scanned documents separate from the remainder of the series.

A note for researchers, particularly, genealogists and Civil War historians. There is a series of records that includes detailed information about Halfmoon in the Civil War, including service

records and other data. There is also a good deal of material about the Grand Army of the Republic chapter in the town that includes much of interest about the charitable activities of the GAR in Halfmoon. Family historians will find that the Board of Health and Overseer of the Poor series include records with information for marriage and deaths and the Overseer has records of the poor receiving relief that often include not only the name of the person receiving assistance from the town, but their age, the reason for needing relief and their county, state or country of origin. Of course, many of the other series of records have records that are the primary resources for anyone researching various aspects of the history of Halfmoon.

Town Boards and Board-Appointed Committees:

Minutes of Town of Halfmoon Board of Supervisors, 1786-2013

This is a series of minutes of the meetings of the Town Board of Supervisors of Halfmoon, NY and includes bound volumes and minutes in 3-ring binders. The Town Board met annually from 1788 mainly to elect town officers and to assign road construction; by the late 19th c. the Town Board met annually, but had regular Special Meetings as well. About 1901 the Board began to have regular meetings about once per month and continued to have Special Meetings. There were also Joint Meetings with the Clifton Park Town Board and Waterford Town Board about mutual issues and concerns especially roads and bridges. Meetings were held in the homes of various town residents, in hotels and later in the 19th century at the Town Clerk's Office. The minutes have loose correspondence, reports, orders, and so forth inserted into the volumes. These have been left in place as found. Indexing of minutes in the volumes begins in 1981.

The minutes include information about a variety of topics of interest to the town and Town Board. These include:

Election of town officers, laying out of roads, Board of Health reports, town audits, designation of polling places, canvassing of votes, bridge building, minutes of joint meetings with Town of Clifton Park and Town of Waterford, correspondence received by town, maps, Justice of the Peace, hydroelectric dams on Hudson River, bond issues, claims for compensation by the town, relief of indigent and poor Civil War veterans, school district reports and funding, health officer's reports of quarantined persons, bid and specifications for road, bridge and other work in the town, overseer of the poor reports, street lights, ordinances and permits re: baseball, bathing beaches, camps, etc., volunteer fire companies, fire district extensions, town borrowing, memorial resolutions, WPA projects, various funds (bridge, highway, machinery, snow, welfare, health; issuances of chattel mortgages, hunting and fishing licenses, dog licenses, marriage licenses, tax assessor, tax collector, petitions re: fire protection districts and water districts, ordinances re: vendors, peddlers and auto parts dealers and mobile homes, annual reports (statistical) of town departments, zoning, sewage disposal, lighting districts, water districts, legal notices, resolutions, contracts, invoices, change orders, Justice court reports, cable television, Town Attorney, Town of Halfmoon Master Plan, library tax district, insurance, septic systems, landfill closures, flood damage, fuel oil bids, subdivision regulations and construction standards, environmental assessment, grants, quarries, Clough-Harbor, Planning Board, Interpower, Halfmoon town employees appointments, salaries, benefits, etc., Local Laws, Senior Citizen Center, recreation, Saratoga County, Crescent Trail, transcripts of testimony at meetings, Boy Scouts, Mechanicville and other topics.

Volume No. Date:

Minutes of Town of Halfmoon Planning Board, 1964-2013

This is a series of the minutes of meetings of the Halfmoon Town Planning Board beginning in 1964 and running to 2013.

The minutes begin with the organizational meeting on February 13, 1964. That meeting had the Town Board appointing the Planning Board members and officers and setting the date for the following meeting in March 1964. At this first meeting, the duties of a Planning Board were explained and the Town Board explained why they believed a Planning Board was needed.

Minutes are in 3-ring binders, vols. 1-2 are handwritten in pencil and pen. Later minutes are typed. Topics include site plans presented for Board approval, statements of approval or disapproval of applications for proposed development or building, correspondence received by

board, reports from surveyors and others, memoranda re: environmental issues, correspondence, etc. re: to specific development proposals, zoning issues, legal notices published in the Townsman, site inspection policy, Clough-Harbor reports, transcripts of testimony before Planning Board.

Planning Board deals with site approvals for residential and subdivision developments, commercial site development (restaurants, car washes, stores, gas stations, etc.), sign approvals, mobile homes, construction equipment parking, septic system design, land use proposals, parking lots, auto dealerships, use permits.

Minutes of Town of Halfmoon Zoning Board of Appeals, 1979-2013

This is a series of minutes of the Halfmoon Zoning Board of Appeals from 1979-2013. The minutes consist of statements of request for variance from zoning, with reasons for request, notes about any opposition to request, answers to any questions from the Board and vote to approve or deny the request. The variance requests are for both residential and commercial properties. It should be noted that the minutes re: to the request become more detailed and lengthy in recent years. There is also a folder that has a handwritten list of dates for which minutes are missing.

Records of the Town of Halfmoon Ethics Committee, 2012

The Town of Halfmoon created an Ethics Committee by a Local Law, 2-1970 in 1970 to ensure "proper ethical conduct of its public officers and employees." This is a single binder of minutes of the Ethics Committee for 2012 and includes a draft revision of the 1970 ethics law; also an article about municipal ethics boards and confidentiality of their proceedings.

Minutes of meetings of Town of Halfmoon Youth Commission

This is a series of minutes of the Halfmoon Youth Commission contained in 2 post binders. The Youth Commission was established in 1983 and had its first meeting May 9, 1983. The purpose of the Youth Commission is to "decide what types of programs and activities the people desire in the Town of Halfmoon and to also develop parks and other youth facilities which could be used for summer programs or year round programs." The minutes include discussions about programs, parks, activities, budgets, staffing of town recreation programs, summer programs and other issues.

Financial Records of the Town of Halfmoon (Bound Volumes)

The following are several volumes and folders of financial records of the Town of Halfmoon.

Supervisor's Budget Book, 1856-1898:

This is a one volume account book kept by the Halfmoon Town Supervisor and audited by the Town Clerk and Justice of Peace. It includes accounts of monies received from excise taxes, school funding, dog tax, fines, etc. by and paid to various town employees, residents and other villages by the Supervisor. Money was paid to inspectors of elections, overseers of poor, assessors, highway commissioner, for reports of births and deaths and others.

Book of Indebtedness, 1934-1951:

Record book of the loans of the Town of Halfmoon from the Bank of Waterford, NY, 1934-1951, includes amount borrowed, interest rate and date to be repaid.

Register of Bonds of the Town of Halfmoon, 1941-1980:

Record book of bonds issued by various banks to Halfmoon for various purposes, incl. revenue anticipation notes, tax equalization, water district serial bonds, trucks, bulldozer, and others, 1941-1980.

Minutes of Meetings of Town of Halfmoon Board of Auditors, 1894-1921:

This is a minute book of the Board of Auditors of Halfmoon and includes meeting minutes from March 1894 to August 1921. The Board examined bills and accounts submitted for payment by the Town and either allowed or disallowed payment. Bills were received from various town departments including the Overseer of the Poor, Highway Dept., jail, and others. Also, loose documents including bill of Overseer of the Poor and permit from same to St. Joseph's House for care of the Stevens child, 1918.

Ledger of Town Audit, 1916-1919:

Ledger of money received and paid as part of Halfmoon town audit; about 25 pp. only of the ledger are used; also, 12 pp. record audited amounts received and paid from various town funds, including Mortgage Tax, G.A.R. Post, Miscellaneous, Sheep, Manufacturers National Bank, Poor, Excise, Justices Fines, General, Corporation Tax, Dog License funds.

Record of Conditional Sale, 1949-1955:

This is a volume of the records of conditional sales of property to individuals from individuals in the Town of Halfmoon. The purchases were chiefly for automobiles, trucks, appliances, and televisions. The ownership of the item purchased did not accrue to the purchaser until the final payment was made for the item. These records are similar to the chattel mortgage records. The records are listed alphabetically.

List of Conveyances of Property in the Town of Halfmoon, 1920-1949, 3 vols.:

This is a series of 3 volumes of lists of conveyances of real property in the Town of Halfmoon. The information recorded included the Grantor, Grantee, consideration amount, and book and page number where the sale may be found in the Saratoga County Clerk's Office. The information is recorded monthly.

Mortgage Book of Town of Halfmoon, 1855-1942:

This is a book of mortgages recorded by the Town of Halfmoon, 1855-1941. The records include the name of the Mortgagor, Mortgagee, date of mortgage, amount secured, when due, date of filing of mortgage, renewal and remarks. The volume is in alphabetical order.

Chattel Mortgage Record Books 1895-1915 and 1942-1962.

This is a record of transfer of the right in personal property as security for the payment of money. The loaner owns the property until such time that buyer makes full payment for the property. Chattel mortgages were used to buy cattle and horses, automobiles, appliances, furniture and other goods; also used by factories to buy equipment and other materials. Chattel mortgages were used until other secured transactions (car loans, credit cards) took their place. They are important records of the types of personal property being purchased by consumers and corporations before the late-20th century. Many of the records in these volumes are purchases made in the Village of Mechanicville (part of Halfmoon until 1910). The data found in these records includes name of mortgagor, name of mortgage, date of mortgage, name of the property (car, cow, tractor, etc.), amount of mortgage, date mortgage due, filing date of mortgage, and other miscellaneous data.

Certificates of Indebtedness, 1915-1916

A folder of Town Board resolutions of certificates of indebtedness of money borrowed to pay the debts of the town, 1915; also, a list from the Saratoga County Clerk of the stock corporations that filed incorportation certificates for the Town of Halfmoon, 1916.

Cancelled Checks, etc.

A folder of cancelled checks of the Town of Halfmoon on the Manufacturer's National Bank, 1915-1916 and the First National Bank of Mechanicville, 1893-1897; also a small group of receipts for goods and services purchased by the Town of Halfmoon, 1886-1905.

Town Clerk

Record of Ordinances, 1935-1968

This is a single bound volume of Local Laws and Ordinances of the Town of Halfmoon, 1935-1968, with originals, photocopies and printed copies of various ordinances re: to dumps, tax exemptions, sewage, mobile homes, zoning and other issues of concern. The papers are not pasted in the volume.

Vital Records of the Town of Halfmoon:

New York began statewide registration of births, marriages, and deaths ("vital records") in 1880-81, under supervision of the state and local boards of health. Compliance with the law was

incomplete until 1913 or even later; therefore certificates may be lacking for many events. The records were kept at the town level and copies were also collected by the NYS Department of Health. The Town of Halfmoon's records are nearly complete from the time that the state law went into effect.

This is a large series of bound volumes and binders of the records of births, marriages and deaths of the Town of Halfmoon. The information found in the vital records varies, including more or less data. The following indicates what information is found for each volume. Most of the categories of information in the vital records is noted, with some non-essential items not noted. This is an important resource for genealogical research and for legal purposes for individuals.

Volumes 1-17 are bound. Volumes 18-42 are 3-ring binders.

Vol. 1: Register of Births, 1882-1899 (one birth 1876 and a few after 1899): Date of birth, family and given names, sex, no. of mother's previous children, how many living, color or race if other than white, place of birth, maiden and married name of mother, mother's age, mother's birthplace, father's name, father's occupation, father's age, father's birthplace, medical attendant or other attestant, when registered and registered number.

Record of Still Births, 1885-1902: Date of birth, sex, color, month of pregnancy, cause of dead birth, mother's name, nativity of mother, residence, name of person making return, undertaker, place of burial

Register of Deaths, 1882-1899: Date of death, name of deceased, age, marital status, occupation, birthplace, how long a resident, father's name and birthplace, mother's name and birthplace, place of death, cause of death, time from attack until death, medical attendant or other attestant, place of burial.

Register of Marriages, 1882-1898: Marriage date, husband's name, his residence, age, race or color, occupation, husband's birthplace, father's name, number of husband's marriage, mother's name, maiden and married name of wife, her residence, age, color or race, wife's birthplace, her father's name, her mother's name, number of wife's marriage, name and official position of person solemnizing marriage, when registered and registered number.

Chattel Mortgages (individual mortgage documents), 1856-1894 1 cu.ft. (1 box)

These are individual chattel mortgages held in the Town of Halfmoon, including the City of Mechanicville, of the right in personal property as security for the payment of money. The loaner owns the property until such time that buyer makes full payment for the property. Chattel mortgages were used to buy canal boats and equipment, cattle and horses, home furniture, groceries, farm equipment, farm crops, billiard tables, blacksmith tools, office furniture, pianos; also used by factories to buy tools and equipment. Chattel mortgages were used until other secured transactions (car loans, credit cards) took their place. They are important records of the types of personal property being purchased by consumers and corporations before the late-20th century. Many of the records in these volumes are purchases made in the Village of Mechanicville (part of Halfmoon until 1910). The data found in these records includes name of mortgagor, name of mortgage, date of mortgage, name of the property (car, cow, tractor, etc.), amount of mortgage, date mortgage due, filing date of mortgage, and other miscellaneous data.

Dog Licenses:

A small booklet listing dog licenses issued in 1890. (Files in box of Oaths of Office)

Commissioners of Highways:

The first state law concerned with highways was passed in 1797 and established what was known as the Labor System, whereby property owners were assessed a number of days (corresponding to the value of their property) to work on the town roads, usually with a team of horses. By a state law passed in 1873 the towns were given the option to replace the assessment of labor by property owners with a monetary tax. The town highway commissioners would estimate the cost of maintenance of the roads and contract out the work. The need for good roads increased as the population of the town grew and new modes of transportation were introduced at the end of the 19th century (bicycles and motor cars). The town commissioners of highways were responsible for the construction of town roads, their maintenance and repair and for the purchase of equipment and supplies to maintain the roads and bridges. The 20th century brought many changes to the road system and its funding with increased state and federal funding for highway construction and maintenance.

This series includes the records of the Town of Halfmoon Highway Department and the records of the Pathmasters of the town as well as some records of Fence Viewers. The Commissioners of Highways were responsible for any new construction and major repairs to roads, bridges and highways in the town. Regular road maintenance was the duty of pathmasters. The pathmasters, who were appointees, were required to get neighbors and others along the designated road, to work their assigned days doing road work.

Box 1:

Pathmasters:

Most of the pathmaster records are lists of inhabitants along roads who were liable to work a certain number of days maintaining the roads. The pathmaster recorded their names and number of days to work. Records of names are usually listed by road district.

The records include:

Road Warrants:

This is a series of records that are similar to the Pathmasters lists of persons assessed for road labor. They are orders from the Town of Halfmoon Commissioner of Highways to the Overseers of Highways in various road districts of the town to assess listed persons for road labor or the persons may commute their labor by payment of \$1 per day. The Overseers are also to remove weeds from the roads, to report the names of all persons who have not worked on the roads or not paid the commutation fee of \$1. They are also to report the numbers of days worked by each person or commutation paid, the number of days not worked by others, numbers of those who paid a fine for not working and all monies collected are to given to the Commissioner of Highways. The following are the years for which there are road warrants. There seem to have been as many as 50 road districts, although the number varies. The road warrants for any specific year are not complete; there are usually several road districts represented, but not all. The villages of Crescent and Mechanicville are also included in some of the years of warrants. There is a Road Warrant form that was used by most Overseers, although many Overseers sent their list of assessed workers to the Commissioner of Highways in a letter or postcard. Many of the records are entitled "Notice to Overseer of Highways of his Appointment and List of Inhabitants," though these are just another form of the road warrant.

Fence Viewers

This is a small series (4 folders) of records of the fence viewers in the Town of Halfmoon and is filed with the Highway Department records.

The Fence Viewers duties seem to have been chiefly to appraise the value of sheep killed or injured by dogs in the town. The documents are mainly certifications that the fence viewers were asked by sheep owners to appraise the value of sheep killed or injured. The fence viewers appear to also have been Commissioners of Highways because the names of commissioners are found as the appraisers throughout this series. The documents date from 1878, 1881 with most of the documents dated 1891-1909.

Some Fence Viewer documents that have been scanned, incl.: certification of fence viewer that sheep owned by Patrick H. Byrnes killed by dogs, 1887; claim of Nicholas Vischer, a fence viewer, for viewing and appraising value of sheep killed by dogs, 1887; certification of Edward McDonnell, Assessor and Nicholas Vischer, Commissioner of Highways and others that sheep owned by Edgar Holmes and others that were killed by dogs, 1876, 1883, 1884, 1885-1888, 1894-1896, 1899-1900, 1903, 1908; also claims made in 1860 and 1878.

Fence Viewer records which were not scanned include certifications of fence viewers that sheep were damaged or killed by dogs on various farms and claims for damages against town accounts. The records date mainly from 1892, though there are a few earlier (1878, 1881) and several later (1894-1908).

Board of Health

Board of Health of the Town of Halfmoon, Minute Book, 1882-1913

Minute Book of the Board of Health of Halfmoon including organizational meeting minutes, July 5, 1882, and minutes of meetings, 1882-1913. Minutes of July 22, 1882 includes the Orders and Regulations to adopted by the Board of Health for the governance of their work, pp. 4-14; also a printed copy of the orders, pp. 79-80. Board dealt with sanitation complaints, contagious illnesses, midwives and births, and many other issues. There is also folder of loose documents found in the book including nuisance complaints, and printed copy of NYS Board of Health regulations re: illuminating oils, adulteration of food and drugs, forms for delayed certificates of vital records and letter re: to registering vital records in New York State communities. The Town Accounts series includes many bills for medical services by various physicians in the town as well as orders from the Overseers of the Poor and others to provide medical services to the poor.

Claims by Board of Health: These are folders of claims made by members of the Board of Health, 1892-1896, 1897, 1899, 1902, 1908, and 1911. The claims were made for attendance at Board of Health meetings and burials, but mainly recording marriages and issuing death certificates. The names of both partners are given in the marriage record and names of the deceased and date of the recording of the marriages and death are given. (Folder files in the box of Oaths of Office); also a report by a physician, 1904.

Overseers of the Poor:

Overseers of the Poor would judge whether persons were in need of minimal aid. They also examined whether persons were deemed settled in the town. Overseers of the Poor were local officials, like selectman or freeholders. Meeting the eligibility requirements for relief was not easy. Widows or elderly were often granted small amounts of aid at home. Within a budget from town taxes, the Overseer of the Poor could provide food, fuel, clothing or money to spend at a local store to purchase the needed supplies by the poor family. They could also order a local physician to provide medical treatment which would also be paid from the Overseer's tax-funded budget. Burials of those on relief might also be paid for by the Overseer. The Overseer is named the Poormaster in some records, mainly late 19th and early 20th century.

Record Book of the Overseer of the Poor, 1895-1914:

This record book has two sections as follows:

Names of Poor Persons, including the first and last name of the person, age, sex, native country, and cause of pauperism. This section is important as a genealogical source because of the detailed information about each person listed. Most of the native countries listed are United States, Ireland, Italy, France, Poland and Canada. The causes range from varieties of sickness, old age, unemployed, desertion by husband, children, husband in army or in prison and others.

Financial account of Overseer of the Poor, including: Moneys Paid Out, When, To Whom Paid and On What Authority (usually Overseer or Town Supervisor). This section has the names of the poor who received a variety of assistance (named in record), but does not include any other genealogical information besides the person's name. There is a folder of loose documents found in the volume, including poormaster accounts, certificates of the Overseer that relief is needed and others.

Overseers of the Poor, 1855-1916

These are orders to provide relief from the Town Supervisor to any Overseer of the Poor and from the Overseers to various physicians and others to provide services to those on relief as well as statements of claims for reimbursements for expenses for goods and services provided in the care of the poor in the Town of Halfmoon, including the City of Mechanicville. The goods included clothes and shoes and receipts for groceries. The documents include the names of the person(s) or families cared for; also orders of the Justice of the Peace or Town Supervisor to the overseers to provide temporary relief to people named in the order for amounts not to exceed variable amounts. The overseers included Thomas E. Hickey, Dorus E. Francisco, Alonso W. Grandy, Chas. H. Paris, Abram Dutcher, Thomas J. Sweeney, J.H. Cowen Jr., Charles Scouten, James H. Sickler, and A.D. Pelkey. There are also orders of the overseers to doctors to provide medical aid to named poor person(s). Also, one Annual Report of the Overseer of the Poor, 1897 that includes the name of the overseer, names of the poor with their age, sex, native country, cause of their need, and dollar amount of relief provided. Also, physicians' claims for reimbursement for services provided (mainly Dr. G.S. Murray; also Dr. J.C. Dow, Dr. Frank A. Palmer, Dr. C.W. Keefer, Dr. Wm. Van Doren, Dr. A. C. Kniskern); also physicians' bills for services in 1893 for surgery, "confinement" of women, medicines, and office visits. There are also claims for burials of those on relief from funeral directors. Also, oaths of office of Overseer of the Poor, 1862-1873, 12 oaths, and bonds (3) of the overseers, 1872.

Board of Elections

The Saratoga County Board of Elections is a bipartisan department with the responsibility for administering elections in the county. The Town Clerk in Halfmoon has the responsibility of preserving election records that are either required by law to be kept permanently or are kept for historical information about the town and its residents. There are a variety of election records including names of voters, election results, names of candidates, and records of expenses of election officials.

Halfmoon Election Districts:

This is a one page geographic description of the boundaries of the election districts in the Town of Halfmoon in 1914. The delineation of the election districts was done because the Town Board in 1914 changed the number of districts from 5 to 8. The document is very brittle and there are several copies of it as well as a photocopy. Also, typed description of the election districts 2-3 and 5 dated 1905 (3??cop.)

There are also resolutions to alter election district boundaries, 1859, 1877, 1880.

Poll Lists:

The Town of Halfmoon was required to keep lists of residents who were allowed to vote and these lists of voters were kept by district; Halfmoon seems to have had two districts until at least 1889; 5 districts in 1890. The poll lists include names of voters for both local and state elections and for special local and state elections. Each voter was assigned a number that would be used as his (women did not have voting rights until 1920) ballot number. Poll Lists by Address:

These are two lists, one printed and one handwritten, with names and addresses. The lists were found among the election records, so are likely poll lists. The printed list is of names and addresses in Mechanicville (pp. 59-64 only). The second list indicates names along roads in the Town of Halfmoon; this list is a crude hand-drawing of the roads and is on very brittle paper. Neither list is dated.

Election Returns/Certificates of Canvass:

This is a largest part of the election records of the Town of Halfmoon. Elections were held in March and November of each year. The records include Ballot Returns of the Ballot Clerks, Inspectors Returns of Elections and Certificates of Canvass of Elections. The Canvass and Returns of Elections include information such as the number of full sets of official ballots furnished to the election district, number of ballots cancelled, number of stubs, whole number of ballots cast, number of ballots found blank, number of ballots declared void, total number of ballots cast, total number of votes for each office and the names of candidates for each office and the number of votes they received and other data that may be added for particular years. The elections were for local, state and national offices. There are also results for special elections.

There are ballot returns, inspector returns and certificates of canvass for several years. The following years are represented by these records. Most of these records are many pages per year and have been tightly rolled for about a century. Some have been flattened, but most remain rolled and will be difficult to use until flattened.

Oaths of Office and Bonds

Oaths of office are affirmations that a person takes before undertaking the duties of a government office. Oaths were required by the laws of the state before the person could exercise the powers of the office. The oath of office is a statement of loyalty to the U.S. and New York State Constitutions and a statement that they will "faithfully discharge the duties of the office." The oath also often states that the officeholder has not received any monies to influence the election. Oaths of Office in this series are for various town offices in Halfmoon and include those for Assessor, Inspector of Elections, Highway Commissioners, Constable, Excise Commissioner, Supervisor, Town Clerk, Auditor, Overseer of the Poor, Collector, Justice of the Peace, Poll Clerk, Ballot Clerk and other offices.

Most of the oaths also include the bond by the officeholder stating they will be liable for any monies paid to them as part of their duties. Some of the oaths/bonds are called "bail bonds" and some as "affidavits." Some bonds are written separately, but filed with the oath. By about 1895 Inspectors of Elections were also required to sign an additional oath, sometimes called a "statutory oath" stating that they would not try to influence or persuade any voter or place any memorandum into a voting booth to influence the election of any person.

The oaths are usually a printed form that was completed and signed by the officeholder, though many of the oaths are completely handwritten. The bonds were signed by the officeholder usually in the presence of the Town Clerk, Supervisor or Justice of the Peace and signed by those officials.

Appointments, 1863-1896, 2 folders:

Board of Excise Records

Prior to 1896, local governments in New York State had the power to license places that sold alcohol and charge a license fee. After 1896, New York State government took over this function and the towns no longer had the responsibility to charge a license fee for alcohol sales. This series dates from 1873 to 1895 and includes the following records.

Minute Book of the Board of Excise, 1885-1892. The minutes consist of statements that applications and bonds were presented for a license and whether the application was accepted and the license issued and what fee was charged. The applications were received from hotels, grocery stores, druggists and individuals (selling alcohol from their house).

Bonds of applicants for license to keep an inn, tavern or hotel and to sell "liquors, wines, ale and beer..." and to ensure that it not be "disorderly, or suffer any gambling...with the inn..." Bonds were for the penal sum of \$250; also, Applications for a License to sell "liquours, wines, ale and beer:" also, approved licenses for storekeepers; also, petitions from residents of various election districts to approve the application of particular applicants for licenses to see alcohol. The application, bond and petition are usually filed together for each applicant. There are records from the Town of Halfmoon, including the village of Mechanicville and of Crescent. The village is noted on the applications and in later years the street address of the tavern/saloon is given on the application.

School Records

There were school commissioners in the Town of Halfmoon as early as 1796; from 1812-1843 there were a number of school commissioners appointed and there were also many inspectors of the schools appointed. In 1844, there were about 14 school districts and the town appointed a Superintendent of the Common Schools and continued to do so until 1856 when the school districts became organized by Assembly district by state law. In 1878, there were 12 school districts in the town. Most early school records are not extant.

Regarding the records of Special Franchises in this series, the following was taken from online history of taxation in New York State and may clarify the use of these particular franchise records:

In 1899, the State Board of Tax Commissioners was authorized to assess special franchises (the right of railroads and utilities to occupy public streets and public places, including the value of tangible property located therein) and in accordance with the statute, the Board assessed the special franchises at full value. The special franchise assessments determined by the Board were certified to the local assessors who were required to enter the assessments on the assessment roll without change. Since the Board and the local assessor had no power to equalize special franchise assessments to correspond to other property in the locality, the only remedy to procure equalization was by a court proceeding. In 1912, the Legislature empowered the State Board of Tax Commissioners to equalize special franchises.

The equalization of special franchises by the State Board of Tax Commissioners (not to be confused with the State Board of Equalization) produced several factors or by-products which were most significant in the development of state equalization. In this respect any data or information secured for the purposes of equalizing special franchises was made available to the State Board of Equalization. Moreover, the State Board of Tax Commissioners published equalization rates for each city, town and village, which were to be subsequently utilized for various other purposes – such as, apportioning of grants-in-aid, apportioning of taxes among school and special districts and determining tax and debt limitations.

Justice of Peace and Court Records

In New York, the justice-of-the-peace tradition that began in England was continued in various early local courts, including justice of peace courts, magistrates' courts, police courts, and town and village courts, all of which collectively served as predecessors to New York's current town and village court system. The justices who served in these courts were, by all accounts, extremely hard-working, dedicated, and committed public servants, despite receiving little pay and virtually no assistance. Indeed, one prominent study of law enforcement in colonial New York observed that "[n]o one who has examined the now fragmentary records of how the body of [colonial New York] justices applied themselves to their duties can fail to marvel at the pains taken by so many of them to discharge their office." Like their English brethren, justices in New York's early local courts primarily exercised limited criminal jurisdiction over arraignments, non-felonies, and other similar matters. By the eighteenth century, however, New York's Justice Courts had begun to hear some civil cases, and, by the nineteenth century, these courts had risen to considerable prominence within the state. This latter fact was expressly recognized by the Court of Appeals near the end of the nineteenth century in People ex rel. Burby v. Howland; as the Court wrote therein, the state's Justice Court system "is regarded as of great importance to the people at large, as it opens the doors of justice near their own homes, and not only affords a

cheap and speedy remedy for minor grievances as to rights of property, but also renders substantial aid in the prevention and punishment of crime."

The first meaningful reference to the Legislature's authority over the Justice Courts occurred in 1846, when voters enacted a new Judiciary Article of the State Constitution that authorized the Legislature to control the manner in which town judges and judicial officers were elected. The provisions set forth in this Article remained largely unchanged through the end of the nineteenth century and the beginning of the twentieth, though various refinements to the Justice Courts' powers were made during this time. Included among these refinements were provisions allowing localities to establish local courts and elect judges, as well as measures formally establishing jurisdiction over arraignments, non-felony offenses, and some civil matters. (Above paragraphs are quoted verbatim from "Justice Most Local: The Future of Town and Village Courts in New York State," Sept. 2008)

The Town of Halfmoon Justice of the Peace system was an active part of the community with the first JPs elected in 1831. Earlier justice in the town appears to have been handled by Constables and other town officials. By statute the Justice of the Peace courts handle misdemeanors and minor grievances and appeals from JP decisions go to the Saratoga County courts. Most records in this series are for cases of public intoxication, abandonment and non-support of wife and children, vagrancy and tramps, and petit larceny. However, the records here indicate that the JPs seem to have handled some more weighty matters, including assault and battery and rape; serious

The records include warrants and subpoenas, depositions, transcripts of cases before the JPs, search warrants, statements of fines received by the JPs, claims for reimbursement of costs by various justice officials and other material.

cases, however, were usually transferred to the county court.

The records were created by the work of various Constables, Justices of the Peace and Deputy Sheriffs.

These claims include the name of the claimant, criminals' names, crimes, places where imprisoned, mileage, food for prisoner, setting bail, swearing of witnesses, recording sentences, issuing warrants, taking depositions and statements, issuing subpoenas, swearing in juries, as member of town Board of Health and member of Canvass Board, meeting with the Town Board, attending court (Constables), conveying prisoners to penitentiary or county jail, regular salary (Constables appear to have been paid \$200 per year in 1894), receiving complaint, making arrests, meals and fare for travel (for both officer and prisoner), serving as officer at the polls, and other costs encountered in the doing their jobs.

Many of these claims have been partly unfolded and flattened, though there are many that were tightly folded and cannot be used until they have been flattened.

Assessor

The function of the Assessor in the Town of Halfmoon is to maintain a fair and equitable assessment of all real property within the town. In the 19th century and early 20th century, assessors also assessed the value of personal property for taxation and the records here include some of these forms of record.

Town Accounts:

These records are arranged in chronological order by year. The records are chiefly of claims made to the Town of Halfmoon for payment for goods and services. In addition, other record forms may be found in this series, including bonds (aka "undertakings") of various town officers. The records are in the following order: chronological, 1861-1959. Many claims that were filed by office have been kept with that office's files.

Some of the typical claims made for payment are from the Justices of the Peace for their services, including granting orders for relief payments to the poor, Board of Health claims by physicians and by members of the Board for attendance at meetings, Auditors for services with the Auditing Board, Town Attorney for services on various town legal matters, Assessor (often for claims of erroneous assessment), Town Clerk for filing, meeting attendance, etc., Town Supervisor, official election work (Ballot Clerk, Poll Clerk, Inspector), Overseers of the Poor, Fire Warden, Constables and Deputy Sheriffs, Highway Commissioners, Fence Viewers, Commissioners of Excise.

There are also claims for payment by vendors to the town, including for printing, surveying, building bridges, burials of the poor, and for furnishing rooms for town meetings and elections and others. There are also claims by the Village of Mechanicville for use of jail and other claims. It should be noted that while these are chiefly financial records of payments for services by various town officers and vendors, some of the records have information of use beyond the strictly financial data. For instance, the bills paid for submission of death certificates give the name of the deceased and the date, while bills submitted by Deputy Sheriffs and Constables usually include the names of prisoners and their crimes as part of the description of the officers' services. Justices of the Peace were also members of the Board of Health and had oversight of the Overseers of the Poor and their accounts may include names of abandoned children or the names of people receiving poor relief. These latter overseers also often including the country of origin of the person (America, Ireland, England, as well as the age of the person; these records may be good sources of genealogical information.

It may be assumed that each year listed below has typical claims and other records in this series. Unusual or interesting claims are mentioned where found in particular years. In addition, records in other series of the town records, such as the Overseer of the Poor have similar claim records as found in this series. Therefore, anyone researching these claim records should also look in other record series found in the town records.

As in the case of other record series in the town records, all of the records were folded for many decades and are often difficult to unfold (and will remain so until they receive conservation treatment). So, as in the other series, some of the records have been unfolded and others remain in folded.

Record of the Town of Halfmoon, Saratoga County ...in the War of the Rebellion, 1865. (filed with volumes of Vital Records).

This oversize volume is a record of the officers, soldiers and seamen who were part of the troops of the United States from New York State in the Civil War. The volume was compiled on request from the New York State Bureau of Military Record. It includes records of individual soldiers and officers, and officers and seamen. The information about each person includes:

Name, residence, date and place of birth

Rank (usually blank) and Regiment

Company

Place of enlistment

White or Colored

Bounty paid by town

Bounty paid by County (if disbursed by Supervisor)

Promotions, Resignations, Discharges, Death, etc. with dates, causes, etc.

Includes a name index. This is an important source for the part played by the Town of Halfmoon in the Civil War.

Civil War and GAR records:

This is a group of records from Halfmoon relating to the Civil War and Halfmoon's part in the war. Many, possibly most, of the documents in this group have been scanned.

- a. Enrollment of Persons Liable to Military Duty in Company G, Regiment 29th, N.Y.S.M., Capt. W.G. Overacker, Enrolling Office, August 8, 1866. Warren Rulison, Town Clerk. This book gives the name, residence (Halfmoon), age and class (1st or 2nd) of each man. This book is post-Civil War as it is dated 1866.
- b. Names of Men Enlisted to the Credit of Town of Halfmoon, July 18, 1864 and December 1864. (July: paid by Town of Halfmoon and December paid by New York State) Gives name, date and place of enlistment, years of enlistment and total wages to be paid.

Enrollment record, 1 p., Joined for Duty and Enrolled, gives name, rank, age, date enrolled, where enrolled, period of enlistment, notes ca. each person (discharged, deserted, killed, etc.), July-August 1862; also List of Volunteer Enlistments since July 2, 1862 giving name, age, volunteer, regiment (115th, 77th, 125th) and rank.
- d. Descriptive Roll of Persons Enlisted for the Town of Halfmoon, Saratoga County, 18th Cong. Dist., U.S. A detailed record giving: name, rank, birthplace, age, occupation, description of person including when, where and by whom described, einlistment period (3 yrs. or 1 yr.), hair color, eyes, complexion, height, when, where and by whom mustered into service, remarks (name of unit or company) and other columns about

- clothing, bounty etc. (not filled in) except for a section of named people who were substitutes.
- e. Claims for exemption from military service, 1864 (105 claims) and 1866 (15 claims). The claims include reasons such as physical disability (hernia, bad eyesight, or hearing, sick lungs); also firemen and alien (chiefly English and Irish immigrants) not liable to serve.
- f. Affidavits (proxies) of soldiers as absent electors authorizing persons to cast their ballot, including the authorizing document and envelope that contained the soldier's ballot (only one ballot is present, the other ballots probably having been cast). The documents include the name of the soldier, regiment and company, where the soldier is located, name of the person authorized to cast ballot; 1864, 22 proxies.
- g. Minutes of special town meetings, 1864 (March, December) to count votes cast re: bounty tax for town; also minutes of annual town meeting that appointed inspectors of elections.
- h. Statement of accounts to be paid to Town Supervisor and others for work filling out quota of enlistments and for work correcting military rolls, 1864, 1865.
- i. List of Volunteer Enlistments since July 2, 1862; listing names, age, rank and regiment, mainly 115th Regt. with a few for the 125th Regt. and 77th Regt.,

Grand Army of the Republic, E.E. Ellsworth Post # 619, Mechanicville, NY, Records:

The Grand Army of the Republic (GAR) was a large multi-faceted organization (fraternal lodge, charitable society, special interest lobby, patriotic group, and political club) founded in 1866 by Union Army Surgeon Benjamin Franklin Stephenson. The organization was originally envisioned as a brotherhood of veterans who were dedicated to helping other veterans. Each post, which presided over the area of one city, town, county, etc. was set up similar to a Union Army encampment. The GAR was, without a doubt, a powerful political organization. It has been described by many as a "bloody shirt Republican club," and while this may be true, it is overshadowed by the organization's patriotic and social work. It was through the GAR, and the pension lobby, that many soldiers and their families received pensions. The GAR also promoted patriotism through parades, national encampments, placement of war memorials, and the establishment of Memorial Day as a national holiday. (The above abstracted from the NYS Archives website).

The Elmer E. Ellsworth Post No. 619 located in Mechanicville acted as a charitable organization in the Town of Halfmoon. Under the provisions of the Laws of 1909 of New York State, the Post passed a resolution to supervise the relief of poor veterans and their families and they signed a bond with the Town of Halfmoon to handle that relief within the town, April 2, 1913. The post had provided relief for several years previously as well. The largest group of GAR records here consists of several folders of recommendations for relief, orders and check stubs of the Relief Committee of the GAR Post #619 to purchase groceries and coal and for bills of doctors, hospitals and funeral expenses for named persons needing relief along with the bills from grocers, etc., all dated 1914.

GAR documents, as follows:

- j. Notice that the G.A.R. Post would provide relief to indigent soldiers, sailors and marines or the families of deceased in accordance with state law of 1887 and it names committee members including Col. E.D. Ellsworth. Also notices as above issued in 1888, 1889, 1890 and 1891. Also, bills for goods and services paid by the G.A.R. Post #619 for repairs to graves, flowers, flags, ammunition and a carriage use, etc., 1894-1901; also two petitions, 1897-1898 by GAR Post to the town asking appropriation to cover expenses of observance of Decoration Day (March 3, 1896 and March 8, 1898). Also, checks on G.A.R. account with 1st National Bank of Mechanicville, 1899.
- k. Bills for Decoration (Memorial) Day celebration, 1898, 1903,1905, 1914, 1916-17
- 1. Bond of James W. Smith, Quartermaster, Wm. L. Howland and Fred Packer of GAR Post 619 re: relief of indigent soldiers, sailors, etc., April 1912; also bond of James W. Smith, 1891.
- m. Application of the post to the Town of Halfmoon asking the town to purchase a plot of land in the Clifton Park Cemetery for the burial of military veterans, 1905.
- n. Recommendation of the GAR post that town raise \$600 for relief work.
- o. Petitions requesting that Town of Halfmoon vote to defray the expenses of Decoration Day for the GAR in 1896 and 1897.
- p. Reports of monies spent by GAR Relief Committee from Town Fund, made by James W. Smith, 1913 and 1914 and letter from J.W. Smith to S. Hayner, Town Supervisor, 1914, requesting check for \$300 to be paid to various grocers for their furnishing goods for relief.
- q. Recommendations for payment of relief, and bills, receipts, and checks, etc. for relief provided by the GAR Post #619. Relief included groceries, coal, medical care, incuding hospital care, payment for burials, and clothing. There are also requests from GAR Relief Committee to issue orders for the provision of relief to named persons. Grocers and others who sold food, etc. for relief included A.M. Ryan, Mechanicville, NY, N. Steenburgh, Crescent, NY, W. M. Dalton, Mechanicville, NY, James Argotsinger, Mechanicville, NY, H.F. Barrett, Clifton Park, NY, D.E. Francisco, West Crescent, NY, E. B. Schermerhorn, Mechanicville, NY; Joshua Anthony, coal dealer, Ushers, NY; hospitals that provided services included Albany Hospital for Incurables, Troy Hospital, Samaritan Hospital.

These two reports include text, photographs, maps, figures, tables and charts. The text includes a project history, the environmental setting, including the paleoenvironment, the prehistoric, i.e. Native American background, history of the occupation of the site from prehistoric times to the 20th c., and detailed investigation of the Nessle site. This is perhaps the most detailed history of this part of the Town of Halfmoon ever compiled. This report also includes 2 compact disks on the project including a Non-Technical Summary and copy of the Final Report.

Hector Ayotte Collection
