NOTICE IS HEREBY GIVEN that sealed proposals are sought and requested for Disposal Privilege for Household Garbage, Construction and Demolition Material collected at the Town of Halfmoon Resident Transfer Station in roll off containers, provided by the Town and, delivered to the bidders premises by the Town of Halfmoon Highway Department.

Sealed proposals will be received by the Town of Halfmoon at the Office of the Town Clerk, Town Hall, Halfmoon, NY, Monday through Friday or by mail until January 10, 2024, at 1:00 pm, and the sealed bids received will be publicly opened and read aloud at that time at the Halfmoon Town Hall, located at 2 Halfmoon Town Plaza, Halfmoon NY 12065.

The above items will be awarded by the Town Board to the lowest bidder, to include each item needed for a term of the award for one year, with the Town reserving the right to have a 90-day option to cancel the contract without penalty. At the conclusion of the contract period, the parties shall have the option of two (2), one-year extensions upon written agreement of both parties. In cases, where two or more responsible bidders submit identical bids as to price, the Town Board may award the contract to either of such bidders. The Town Board reserves the right to reject any or all bids or to accept any alternate proposal not significantly altering the bid specification.

The bidder must supply a copy of their DEC permit to accept the waste and debris.

No bids received may be withdrawn by any bidder for a period of thirty (30) days from the date of the bid opening.

IRANIAN ENERGY DIVESTMENT CERTIFICATION

Pursuant to Section 103-g Of the New York State General Municipal Law

A. By submission of this bid/proposal, each bidder/proposer and each person signing on behalf of any bidder/proposer certifies, and in the case of a joint bid, each party thereto certifies as to its own organization, under penalty of perjury, that to the best of its knowledge and belief that each bidder is not on the list created pursuant to paragraph (b) of subdivision 3 of Section 165-a of the New York State Finance Law.

B. A Bid/Proposal shall not be considered for award, nor shall any award be made where the condition set forth in Paragraph A above has not been complied with; provided, however, that in any case the bidder/proposer cannot make the foregoing certification set forth in Paragraph A above, the bidder/proposer shall so state and shall furnish with the bid a signed statement which sets forth in detail the reasons, therefore. Where Paragraph A above cannot be complied with, the Purchasing Unit to the political subdivision, public department, agency or official thereof to which the bid/proposal is made, or his designee, may award a bid/proposal, on a case by case business under the following circumstances:

1. The investment activities in Iran were made before April 12, 2012, the investment activities in

Iran have not been expanded or renewed after April 12, 2012, and the Bidder/Proposer has adopted, publicized and is implementing a formal plan to cease the investment activities in Iran and to refrain from engaging in any new investments in Iran; or

2. The political subdivision makes a determination that the goods or services are necessary for the political subdivision to perform its functions and that, absent such an exemption, the political subdivision would be unable to obtain the goods or services for which the contract is offered. Such determination shall be made in writing and shall be a public document.
